NO PURCHASE NECESSARY

- 1. HOW TO PLAY.** Receive a game piece with the purchase of any large or extra-large hot coffee or extra-large iced coffee at participating Dunkin' Donuts shops in Illinois, Indiana, Iowa, Kansas, Michigan, Missouri, Minnesota, Nebraska, , and Wisconsin.
